


- 1) 將樣品置於平坦之地面上。
- 2) 分別於上 / 下床架放置一床板。
- 3) 放置均佈載重 1000 kg 於上 / 下床架上，持續保持 240 小時。(照片 C、D)
- 4) 移除載重，觀察並記錄樣品結構是否損壞。

2. 床組耐衝擊試驗

- 1) 將樣品置於平坦之地面上。
- 2) 分別於上 / 下床架放置一床板。
- 3) 放置一 70 cm × 70 cm 之鋁合金平板於床板中央。
- 4) 以 300 kg 之重量自高度 50 cm 處自由落下於衝擊平板。(照片 E、F)
